The Nelson Center, a residential treatment facility, serves clients from the age of 5 to 16, both boys and girls. Most referrals are from CPS, or JPD for children with severe behavioral and emotional difficulties. Most have a severe history of physical abuse, sexual abuse, and/or neglect. Some are post-adopt, some are in the process of family termination, some are in the process of family reunification. Individual, group, and family therapy is offered in order to make transition from the locked facility to homes easier for the child and to assist the family in the healing process. Serve 15 clients per week in all modalities using play therapy, art therapy, and parent training. Teach direct care workers to handle severe and dangerous behaviors and assist them in teaching alternate, more appropriate behaviors to clients through cognitive behavioral techniques. Discuss post traumatic issues with clients, staff and families. Assist families in difficulty decisions. Deal with variety of issues such as anger management, battering, suicidal ideations, and sexual assault.

FCA , an MHMR facility, serves clients with ages from 3 to 18. Served 15 to 25 clients per week in play therapy, family therapy, parent training, and group therapy settings. Carried individual clients for long-term therapy, working with the families as needed.
